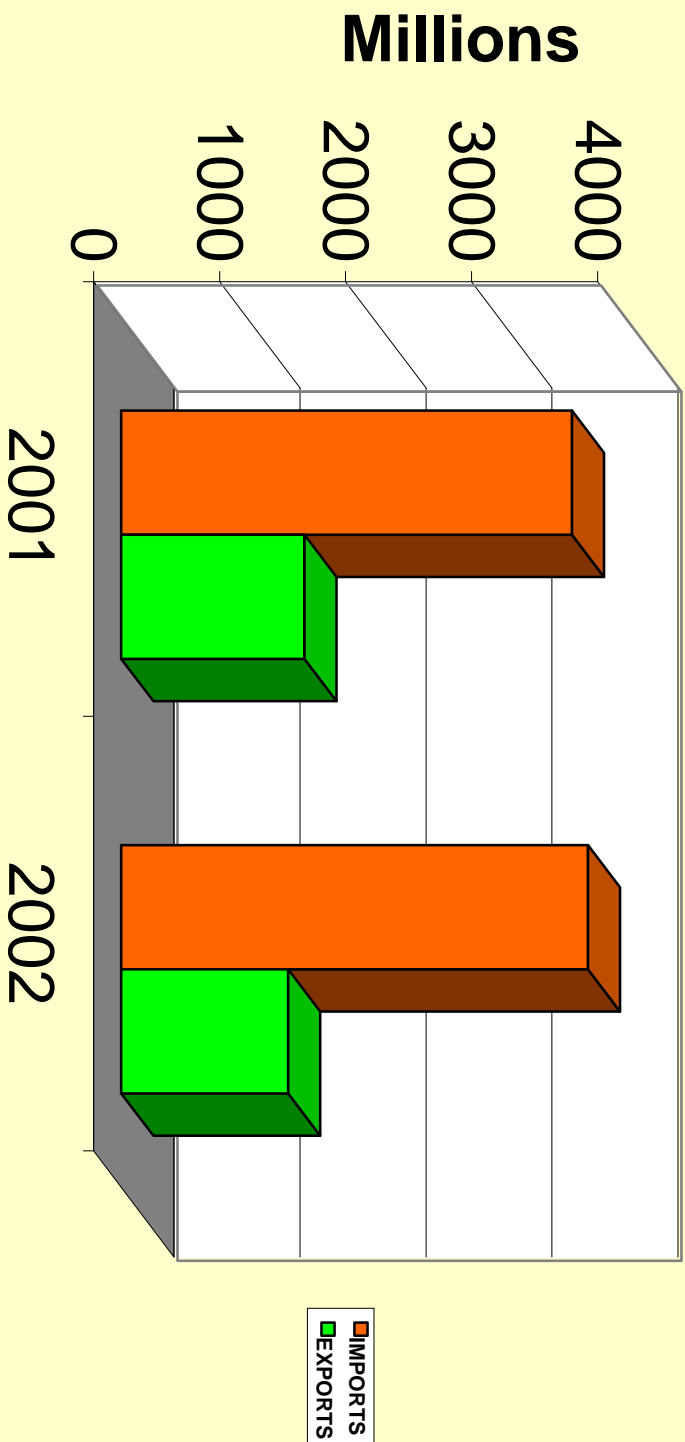

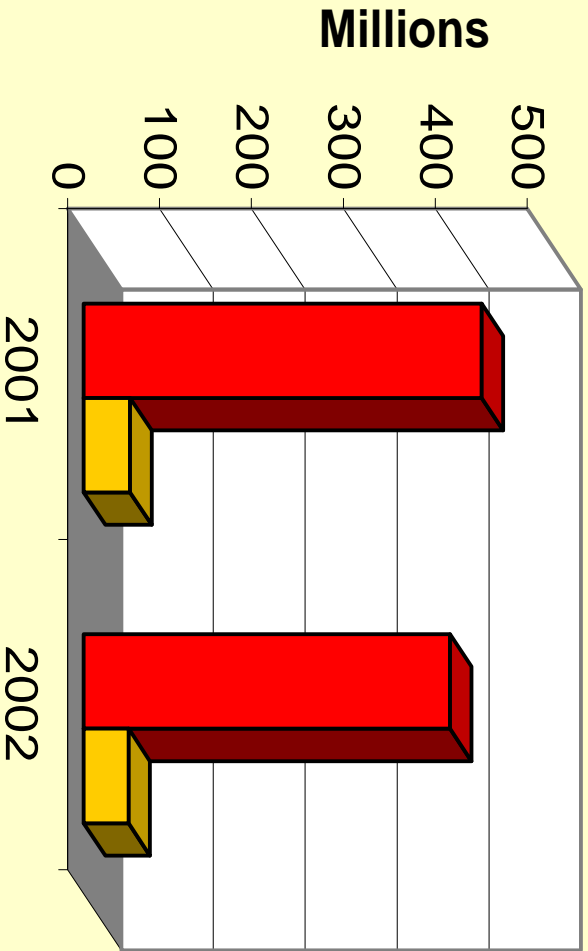

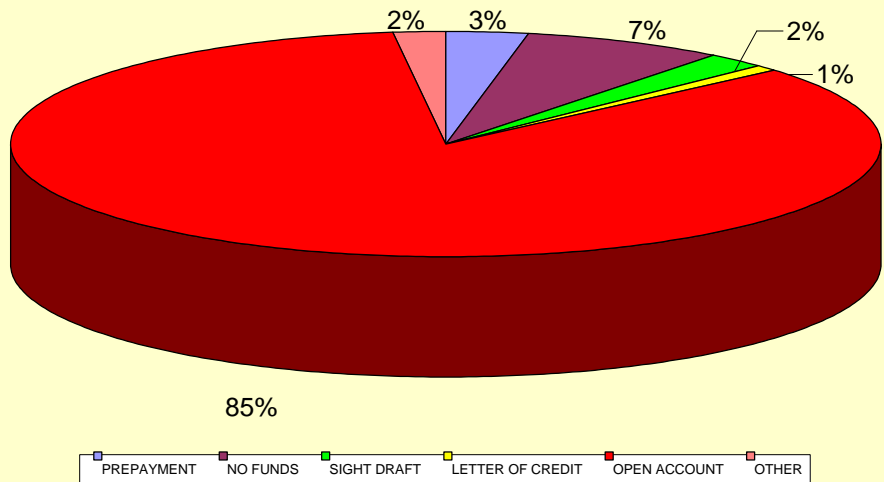

Jan - December 2002



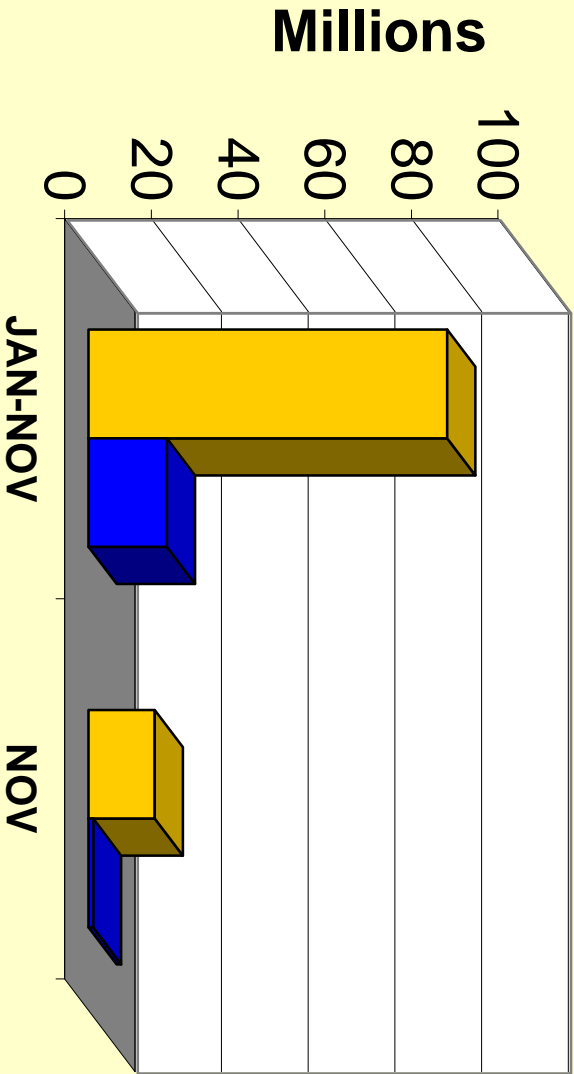

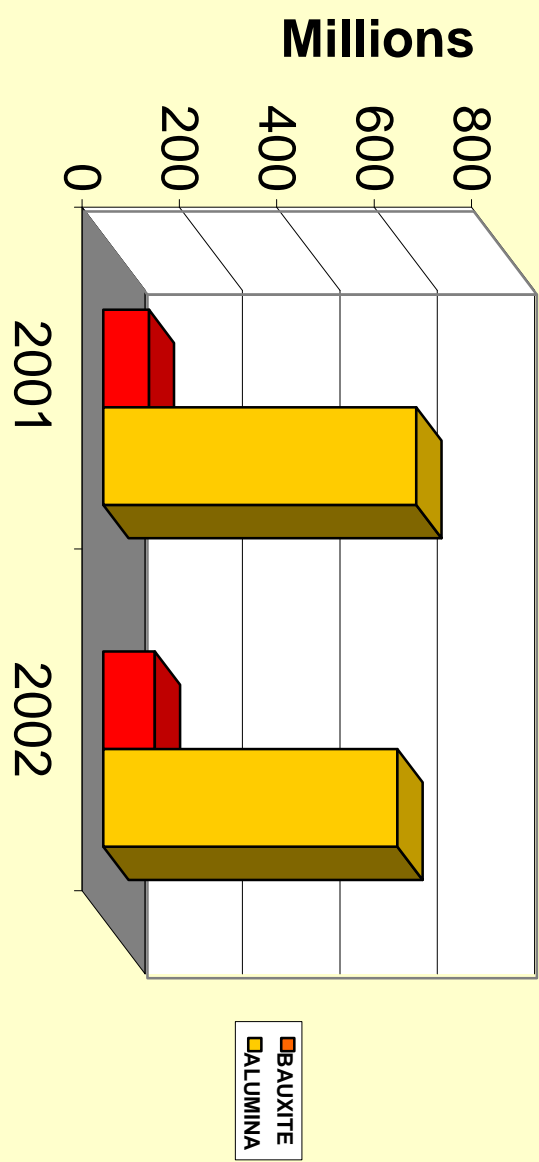
GARMENTS EXPORT US\$Mn

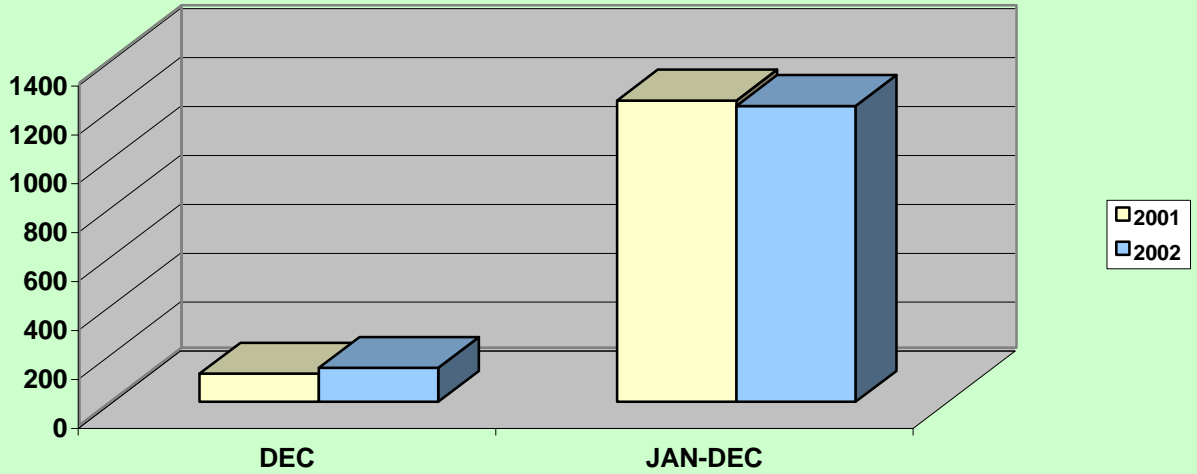

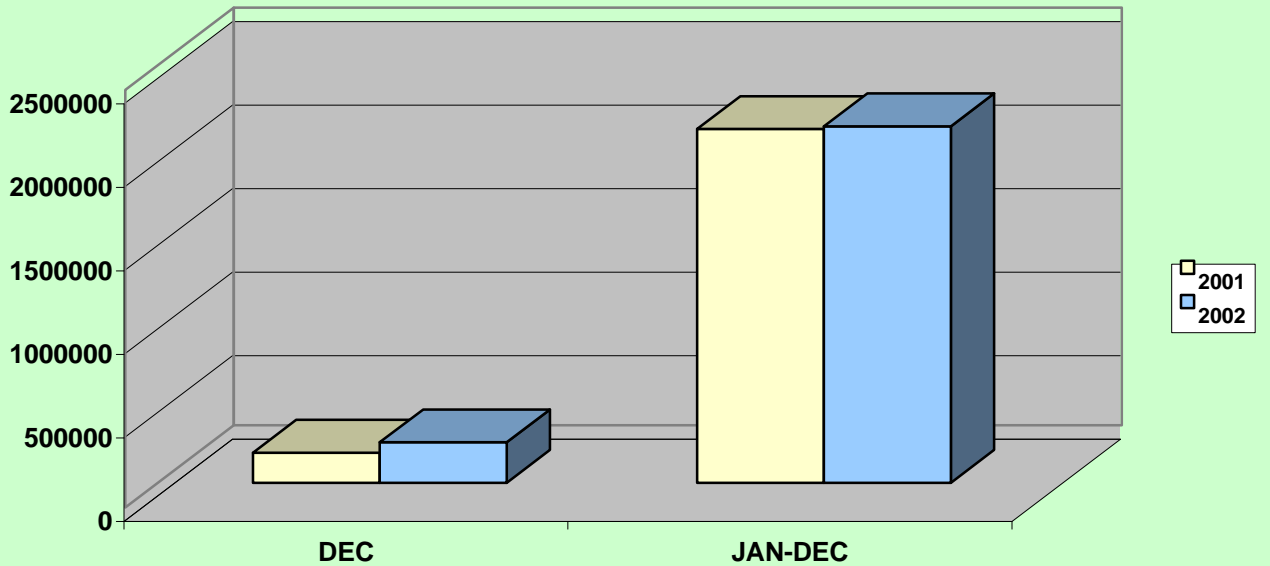

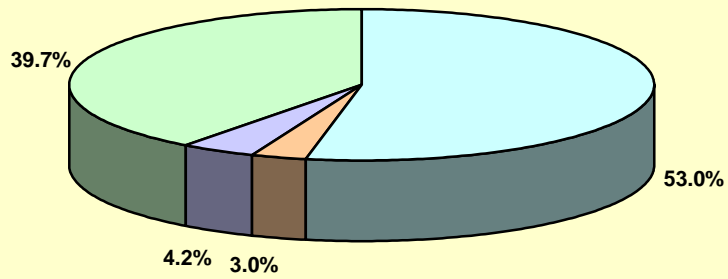
**Estimated Tourist Expenditure

Jamaica: Total Visitors

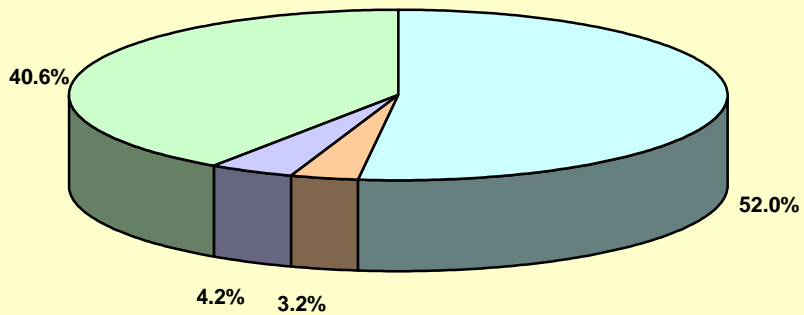


**Composition of Visitors

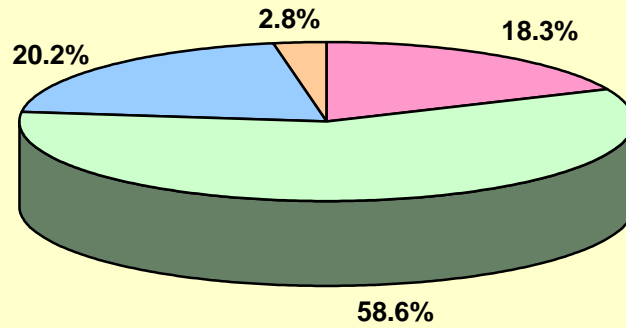

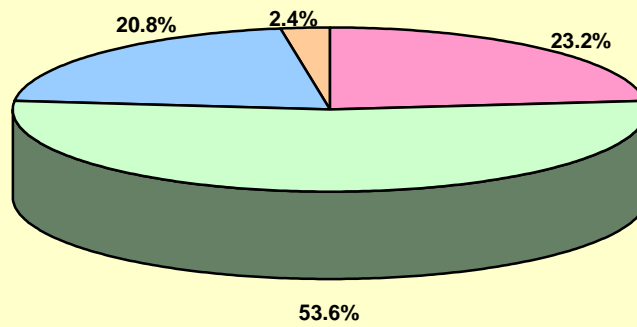
