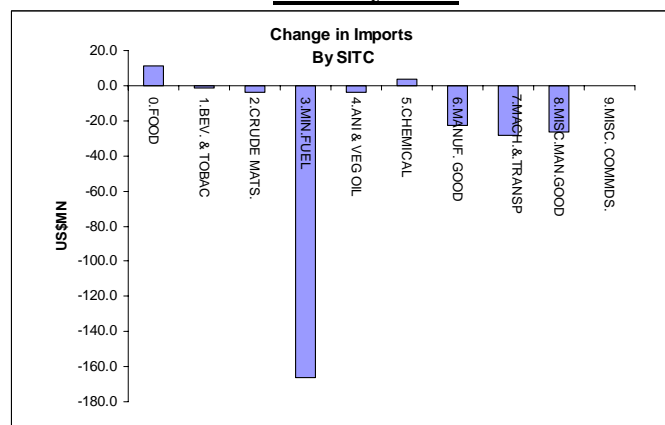

January 2009

For January 2009, there was a current account deficit of **US\$134.5 million**, which represented an improvement of **US\$180.5 million** relative to the corresponding period in 2008. This improved performance resulted from improvements in all sub-accounts (Table 1).

During the month, the goods balance recorded a deficit of **US\$318.3 million**, an improvement of **US\$144.9 million** when compared to the corresponding period in 2008. This resulted primarily from a reduction in imports of **US\$225.4 million**, which was significantly influenced by a reduction in *Mineral Fuel* of **US\$166.3 million** (Graph 1). The improvement observed in the goods sub-account was partially offset by a **US\$80.5 million** decline in exports, stemming mainly from a reduction in alumina exports of **US\$57.0 million**.

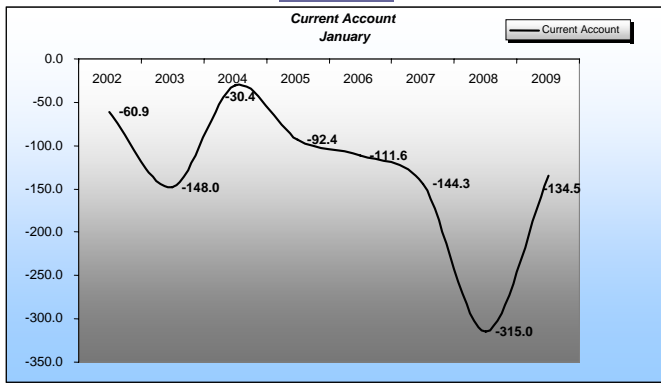
Graph 1

The income sub-account balance improved by **US\$8.3 million** during the review period. This increase resulted from a reduction in profits remitted by foreign direct investment companies. In relation to the services balance, there was an increase in its surplus by **US\$22.0 million**, which resulted primarily from a decline in freight cost, associated with reduced imports.

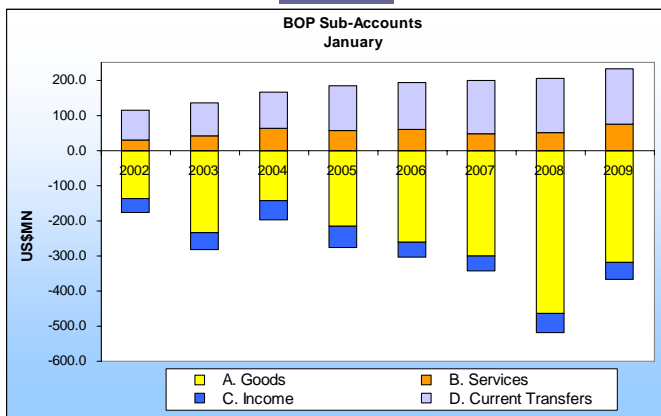

Over the review period, current transfers increased by **US\$5.2 million** to **US\$158.4 million**. The improvement in the current transfers sub-account resulted primarily from an increase in official transfers of **US\$13.2 million**.

Flows from official and private sources were insufficient to finance the current account deficit. Consequently, there was a decline in the NIR of **US\$8.0 million** during the month.

In relation to the historical performance of the BOP, for January 2009, the current account deficit of **US\$134.5 million** represents a reversal of the trend-deterioration observed for the current account in recent history (Graph 2). From graph 3, it can be seen that this improvement results primarily from a reduction in the deficit in the goods sub-account.

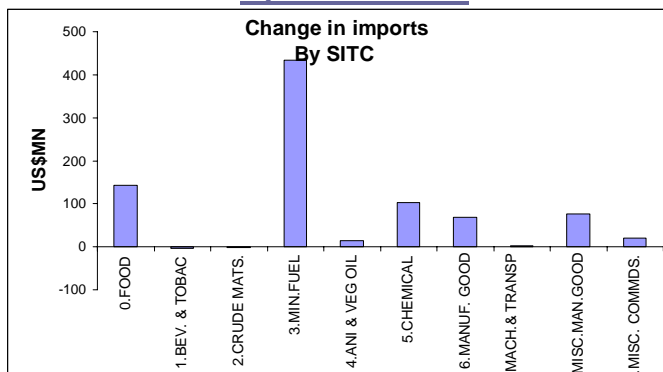

April to January 2008/09

For the first ten months of the fiscal year 2008/09, there was a current account deficit of **US\$2,838.7 million**, which represented a deterioration of **US\$801.1 million** relative to the preceding fiscal year. The deterioration emanated primarily from the goods sub-account (Table 2).

For the goods sub-account, there was a deficit of **US\$4,277.7 million**, which represented a deterioration of **US\$773.4 million** relative to the corresponding period of the previous fiscal year. This performance resulted from an increase of **US\$785.2 million** in imports. The increase in imports was driven primarily by *Mineral Fuel*, which increased by **US\$433.1 million** (Graph 4).

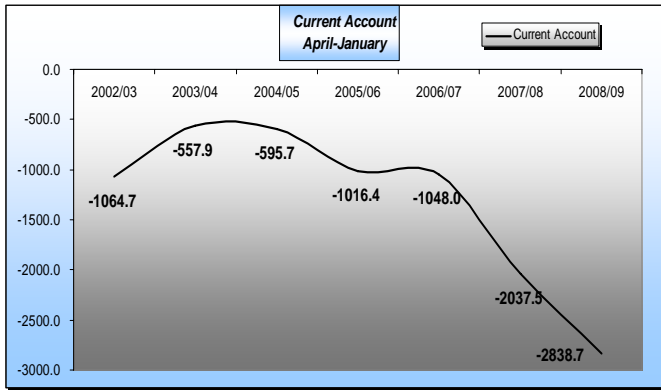
Graph 4

In relation to the services balance, there was a decline in its surplus by **US\$67.0 million**, which primarily resulted from increased freight cost, associated with increased imports. The decrease in net income outflow during the period emanated primarily from reductions in profit remitted by foreign direct investment companies.

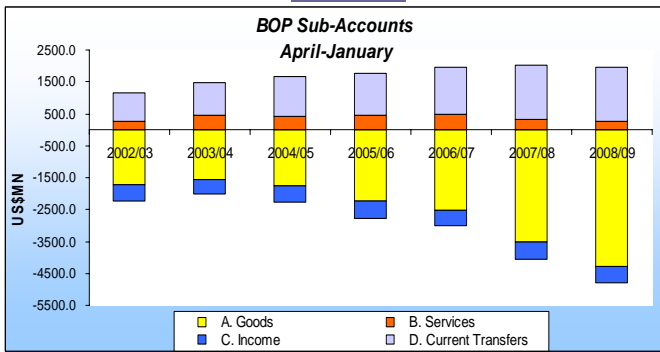

During the review period, current transfers declined by **US\$1.2 million** to **US\$1,720.9 million**. The deterioration in the current transfers sub-account resulted from a **US\$14.0 million** decline in official transfers, which was largely offset by a **US\$12.8 million** increase in private transfers.

Flows from official and private sources were not sufficient to finance the current account deficit. Consequently, the NIR declined by **US\$318.4 million** during the review period.

In relation to the historical performance of the BOP, the current account deficit of **US\$2,838.7 million** for April to January 2008/09 is the largest on record for the country for that period (Graph 5). From graph 6, it can be seen that the deterioration in the current account results primarily from the performance of the goods sub-account.

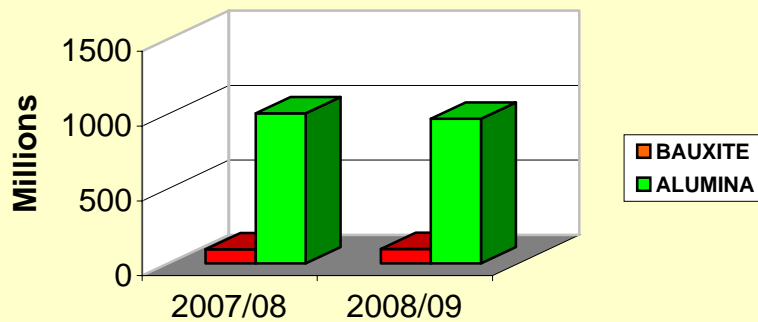

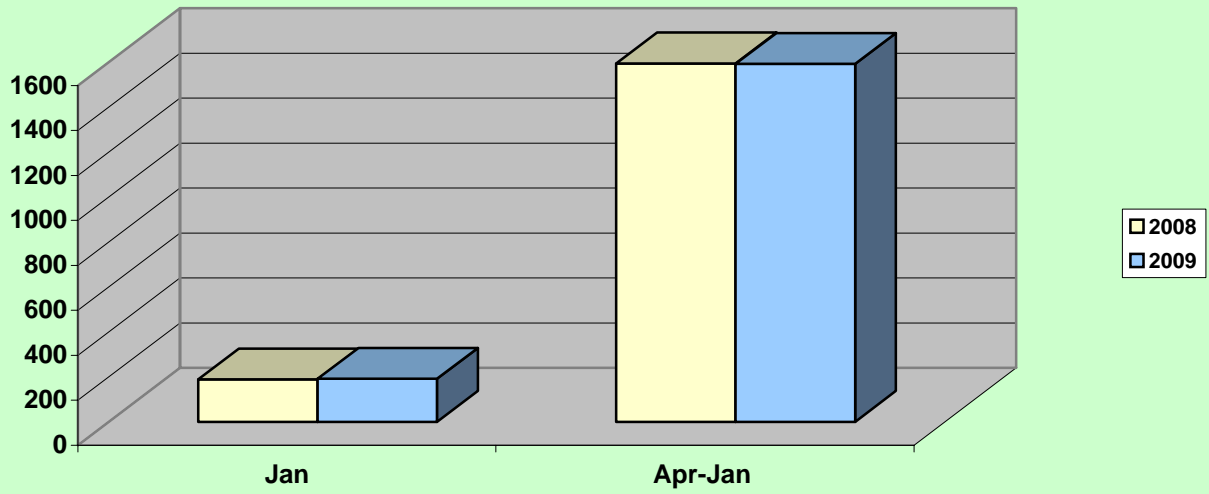

April-January

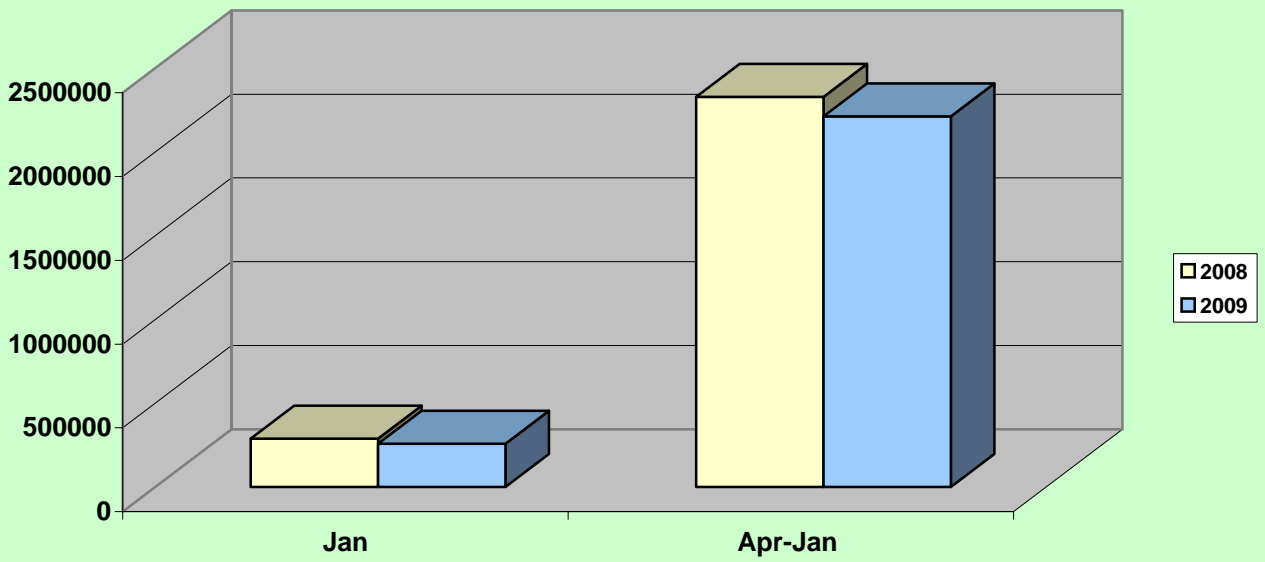

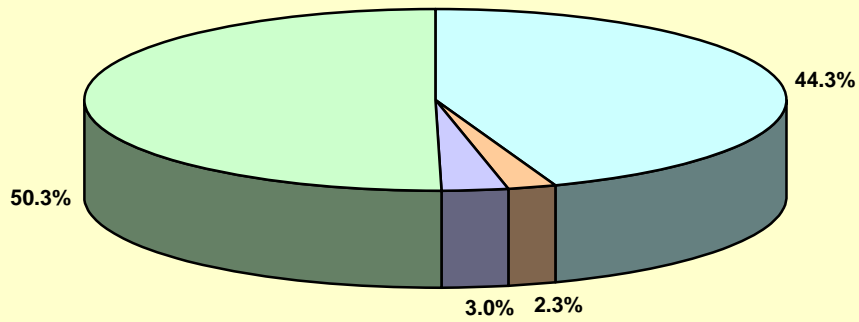
Estimated Tourist Expenditure (US\$Mn)



Jamaica: Total Visitors

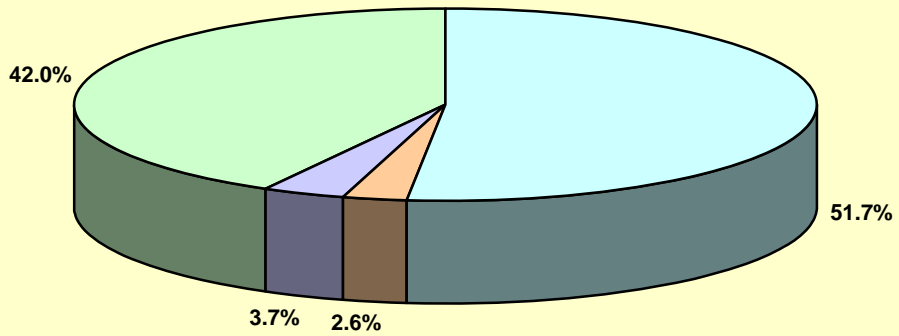


**Composition of Visitors
