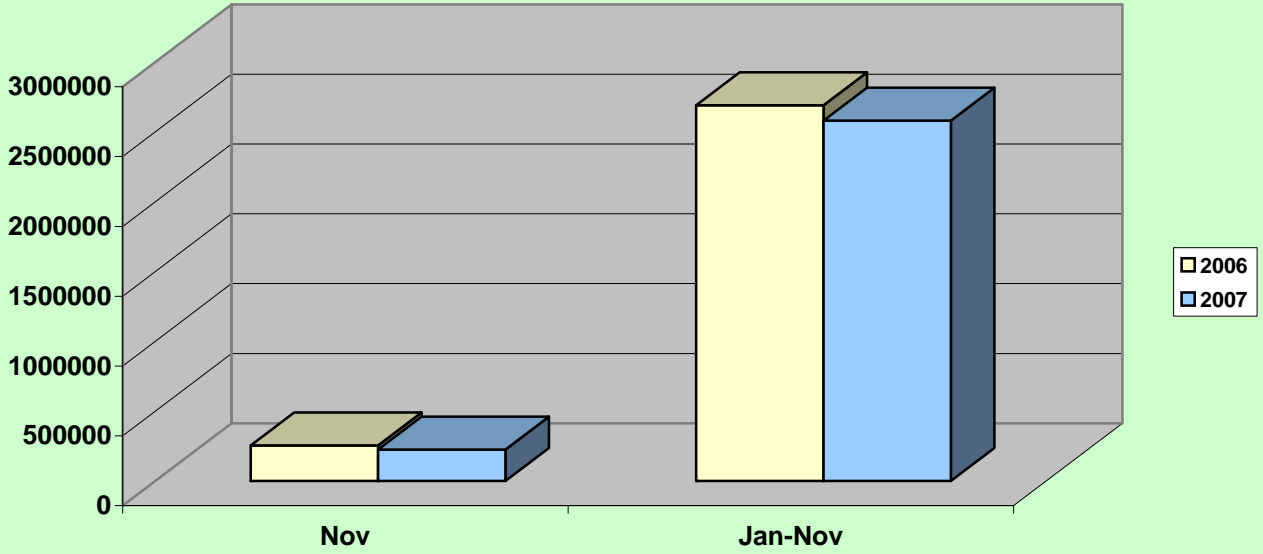

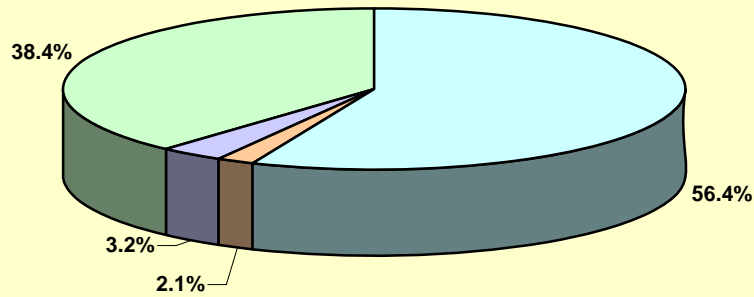
Estimated Tourist Expenditure (US\$Mn)



Jamaica: Total Visitors

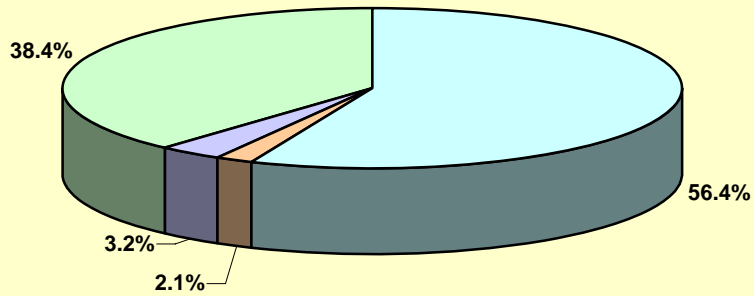


Composition of Visitors November 2006

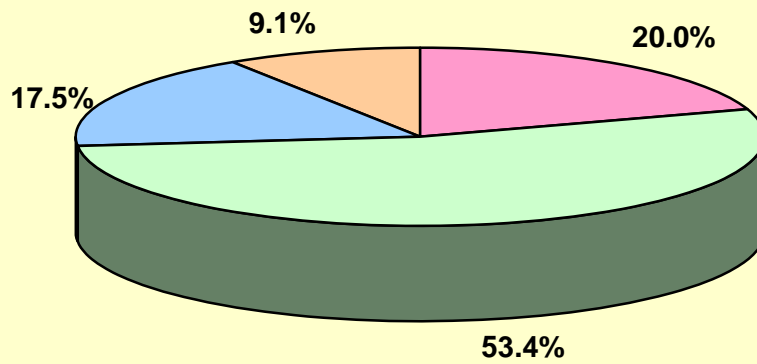

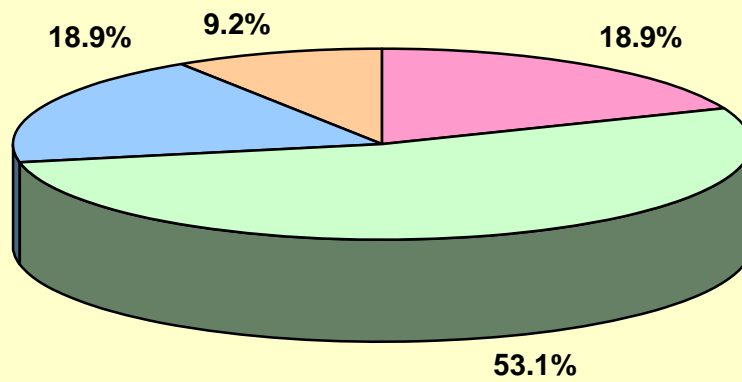
